Requirements for the candidates

- Education in international business administration, accountancy or equivalent.

- Experience within procurement and contracting service, as well as VAT exemption service.
- Knowledge of the Latvian tax law and the ability to apply it.
- Good communication skills and positive attitude towards various stakeholders formally and informally and willingness to learn.
- Proficiency in MS Office and overall knowledge of accountancy management systems.
- Proficiency in English as the primary working language at the HQ is English.
- Military background will be considered an advantage.

Main tasks:

- Assist the Head Contracting in the management of all Division's VAT exemption and reimbursement applications.
- Assist with communication with the Ministry of Foreign Affairs and State Revenue Inspection on all matters concerning exemption and reimbursement of VAT and excise duty.
- Support the Division's deployed personnel to Latvia on VAT exemption and reimbursement.
- Check and prepare all documents for the future exemption and reimbursement of taxes.
- Check decisions concerning VAT and update the Division's internal regulation.
- Maintain a list of contract authority made for Medium Term Financial Plan;
- Monitor contractors' performance, keeping track of past performance records;
- Procure materials and series in the Division in the set scope of responsibility.
- Support the Head Contracting in collecting and investigating contract requirements, preparing invitations for bids and developing contracts.

Headquarters (HQ) Multinational Division North (HQ MND N) was founded in March 2019 as part of NATOs deterrence and collective defence plan of the Baltic region. HQ MND N is located in Adazi Military Base. In peacetime the HQ have operational control of the international forces in the region, and prepares for taking command of divisional forces in case of crisis or war. The HQ also supports the national defence forces in the region with their operational planning and training. The HQ is a part of NATO Force Structure.
