DEFENCE MINISTER'S INTRODUCTION

Defence Minister

Security is the main focus of government budget in 2026, and the national priority of Latvia.

Geopolitical context requires us to act responsibly. Based on sound judgements. With resolve. We are not at war. Neither there is peace. We live under a hybrid war where tensions with aggressor escalate, and we need to strengthen our combat capabilities.

We need to keep arming ourselves. By investing in defence, we are investing in Latvia's security and safety. We need strong armed forces and continued development of military defence capabilities. It is, and will remain, our main task.

2026 defence spending is higher, approaching the mark of 5% of GDP. For the first time ever, it will reach 4.91%. For the first ever, defence investment will exceed 2 billion euro or EUR 2 157 966 637.

We know that each euro must be spent responsibly and wisely. Therefore, accountability, transparency and development will remain key elements of the defence budget in 2026.

The 2026 defence spending priorities are clear:

- First, our people. Our army is as strong as its troops. Professional, ready to engage at all times, technologically advanced and modern. Our regular force will reach 8 000 in 2026 ahead of plans.
- Second, stronger combat capabilities. Capabilities aligned with NATO defence plans. National Armed Forces will receive more than 50 %, making this a combat capability build-up budget. We will invest in air defence, drones and anti-drone systems, innovations and technologies, firepower – infantry fighting vehicles and artillery, equipment and munitions.

- Third, military infrastructure. Selonia Training Area. It is important to conduct top-level allied training activities. We will also invest in counter-mobility barrier and better-protected eastern border of our state.

We will work in conjunction with local companies! That way funding will remain in Latvia. Defence investments will strengthen national economy and boost people's prosperity. 30% of funding will support strategic capability procurements and enhance capacity of national defence sector.

Our ambition is to build a robust national defence sector capable of contributing 3% of GDP in 2028 for our economy.

We will invest in research and development that will drive defence industry growth. Strategic innovations will receive an unprecedented 1.5% of all funding.

Crucially, we will continue to support Ukraine. It will receive 0.25% of GDP or EUR 110 million in 2026.

We will keep explaining our people why defence matters. Freedom is not a gift. It requires commitment and investment. Our society and social partners have been amazingly supportive and positive about that.

By investing in Latvia's defence today, we are investing in peace and future security.

OVERVIEW OF 2026 DEFENCE SPENDING

2026 defence spending priorities include strengthening of National Armed Force combat capabilities, development of defence industry and construction of military infrastructure, including counter-mobility barrier to make the eastern border of Latvia safer.

Defence spending is steadily growing and moving towards 5% of the gross domestic product (GDP). According to the Law on the State Budget for 2026 and the Budget Framework for 2026, 2027 and 2028, adopted by the Saeima (Parliament of Latvia), in 2026 defence sector will receive **4.91% of the GDP or EUR 2 157 966 637**.

DEFENCE BUDGET: 2020 – 2028




Funding for MoD for air defence development

Funding allocated by the government for stronger defence brings **the overall defence expenditure to EUR 2 157 966 637** in 2026 – according to Finance Ministry's latest GDP forecast for 2026 estimated defence spending will reach **4.91% of GDP**.

BREAKDOWN OF 2026 DEFENCE SECTOR BUDGET BY EXPENDITURE POSITIONS



In 2026 government committed to gradual increase of defence and security funding to 5% of GDP through, *inter alia*:

- European Union SAFE facility and defence spending at the level of up to 4.78% of GDP (initiatives under the programme 24.00.00 *National defence and security fund* of the budget chapter 74) to meet NATO capability targets:

- upgrade Mechanised Infantry Brigade by equipping with tailored armoured vehicles and combat support capabilities, such as indirect fire support

- create combat ready division-size support units, such as artillery, air defence and reconnaissance

- stockpile ammunition and develop combat supply capabilities according to national and NATO standards

- support development of unmanned aerial vehicle capabilities at the NAF and improve national anti-UAV counteraction

- in addition to SAFE, additional defence-related funding at the national level and defence budget near 4.91% of the GDP (budget chapter 74 activities) to meet NATO capability targets:

- stronger reconnaissance and threat control capabilities
- development of NAF maintenance and personnel supply framework to ensure faster defence capability implementation
- financing of operations at the Selonia Training Area
- support to Ukraine





COOPERATION WITH DEFENCE INDUSTRY

In 2026, Latvia's defence sector will continue to build closer cooperation with local companies in order to strengthen national security, promote industrial base and growth of the national economy. This goal will be achieved through a vast number of activities – from supporting everyday operations to high technologies and military industrial projects. It will activate local market where companies generate services and products for NAF, while also absorbing large portion of defence spending to create new jobs and develop innovations.



SUPPORTING EVERYDAY WORK OF NAF

200 MLN. EUR

Latvian companies are already taking part in tenders for provision of catering, technical maintenance, military base infrastructure maintenance and management, transport and also other essential services. Procurements create a stable flow of orders to local providers and ensure continuity of NAF operations. Supporting of NAF everyday work is expected to cost around 200 million euro annually.

INFRASTRUCTURE CONSTRUCTION

Local construction and engineering firms implement projects for development of military bases, warehouses and regional training areas. Projects are funded from defence budget and are essential for regional development and national security. 135 million euro will go to construction in 2026.

INDUSTRY DELIVERING LARGE NAF CAPABILITY CONTRACTS

200 MLN. EUR

Ministry of Defence aims to strengthen NAF supply chain by ensuring that local industry delivers 30% or more of the scope of major NAF contracts. For example, there have already been signed NAF capability development contracts for Patria 6x6 APCs, IRIS-T medium range air defence systems, ASCOD IFVs, RBS-70 NG air defence systems, Spike anti-tank missile systems and Skorpion 2 remote mine-laying systems. These projects will extend beyond 2026. These projects are expected to bring around 200mln euro into Latvian economy in the long run.

DRONES

100 MLN. EUR

The new Autonomous Systems Competence Centre combines innovation, research and procurement expertise. It embeds NAF operational needs into development and implementation of new technologies. It facilitates introduction of more modern and safe defence technologies in Latvia. Additional UAV capabilities and Drone Coalition will receive at least 100 million euro in 2026.



STATE DEFENCE CORPORATION, LLC. PROJECTS

13 MLN. EUR

In 2026, State Defence Corporation, LLC. will continue progress on the 155mm artillery modular charge assembly plant in Jelgava. 13 million euro will be invested in the project in 2026. It will be a strategic driver for stronger defence capabilities, development of national defence industry and resilience of ammunition supply chains.


In 2025, State Defence Corporation, LLC. and German military industrial company Rheinmetall signed a Memorandum of Understanding on construction of 155 mm artillery ammunition facility in Latvia. Successful implementation of the project will benefit Latvia's defence and the economy. These projects will also create new opportunities for partnerships with Latvian companies. State Defence Corporation, LLC. is a state-owned enterprise established by the Ministry of Defence.

INNOVATIONS AND TECHNOLOGIES FUNDED IN 2026

In 2026, Ministry of Defence will continue to implement strategically-oriented defence industry and research support policy aimed at ensuring transparent, cohesive and efficient growth of national defence industry and more favourable defence innovation ecosystem. The Ministry of Defence **intends to support new innovations and technologies with 25.9 million euro in 2026.**

INNOVATION AND TECHNOLOGY SUPPORT: EXAMPLES

- **Grant scheme:** annual call for proposals for SMEs developing military and dual-use technologies.
- **Pre-accelerator grants for start-ups** manufacturing military or dual use goods. A contract signed with four Latvian universities in 2025 will deliver national pre-accelerator programme for start-ups.
- **Business accelerator:** support for Unilab Defence, the national accelerator site accredited by NATO DIANA.
- **Fast track:** procedure that ensures faster review of applications for military production by companies.
- **Defence Innovation Fund:** dedicated facility for medium-term venture capital investments in start-up growth to generate innovative military products.

- Support programmes run by Ministry of Economy and EU funds provide additional instruments until 2027 for development of dual use products. Together with the Central Finance and Contracting Agency, support available for internationalisation and development of new products will reach the total of €26 954 264, whereas business productivity development support provided in cooperation with ALTUM will amount to €98 377 792.



DEFENCE INFRASTRUCTURE DEVELOPMENT IN 2026

€135.1 million of national defence funding will be spent on development of military camps and training infrastructure in 2026. In 2026, €116.5 million, or 85% of spending, will go into continuation of priority military construction projects. In addition to priority military infrastructure, funding will also support the development of National Guard bases.

Construction priorities of the Ministry of Defence in 2026:



Defence sector will continue to develop NAF infrastructure. In the coming years, the main focus will be the capability upgrade projects, regional military camps, National Defence Service, warehouses, training and exercise infrastructure required to strengthen regional defence capabilities, create new jobs and promote economic growth of Latvia.

In 2026, defence sector will continue to reinforce military security of Latvia's eastern border, including counter-mobility infrastructure, procurement and on-site installation of counter-mobility facilities.
